In consideration of Variety - the Children's Charity permitting the Entrant to take part in the V2 Motorcycle Run, the Entrant agrees that:

1. The V2 Motorcycle Run is a potentially hazardous to those taking part and the Entrant does so at his/her own risk. The Entrant acknowledges that, Variety - the Children's Charity accepts no responsibility for any Claim or Demand.
2. A comprehensive motor vehicle/motorcycle insurance policy or third party property damage insurance policy for the Participant's vehicle includes adequate cover for the Event;
3. The Entrant will comply with all laws and legal requirements and with all directions of the V2 Motorcycle Run Chairman regarding safety including, but not limited to, requiring Entrants to undergo alcohol breath tests. Variety - the Children's Charity reserves right to conduct breath testing of drivers for blood and drug content. Anyone that refuses or fails to take a test will be immediately removed from the event. Anyone who exceeds the blood alcohol limited prescribed in the conditions of their driver's licence or tests positive for illegal drugs may also be immediately removed from the event. The V2 Motorcycle Run Chairman may also require any Entrant to cease participation in the V2 Motorcycle Run if it is, in his or her opinion, in the interests of safety.
4. This Agreement will not be affected or altered except by Variety - the Children's Charity. The Entrant acknowledges that it has not relied on any representations made by or on behalf of Variety - the Children's Charity.
5. The Entrant indemnifies and holds harmless and will keep indemnified and held harmless
 - (a) Variety - the Children's Charity, from all Claims and Demands, whether known or unknown, by any person against Variety - the Children's Charity arising from or related to, either directly or indirectly, the V2 Motorcycle Run or the carrying out of the V2 Motorcycle Run;
 - (b) each Landowner from all Claims and Demands, whether known or unknown, by any person against the Landowner arising from or related to, either directly or indirectly, the V2 Motorcycle Run or the carrying out of the V2 Motorc
 - (c) each of the Support Crew, from all Claims and Demands, whether known or unknown, by any person claiming through or under the Entrant against members of the Support Crew arising from or related to, either directly or indirectly, the V2 Motorcycle Run or the carrying out of the V2 Motorcycle Run.
6. The Entrant will not advance, institute, prosecute, cause, procure, finance or support directly or indirectly the advancement, institution or prosecution of any proceeding of whatsoever nature, including (without limitation) any examination, inquiry or investigation, against Variety - the Children's Charity or any Landowner jointly or severally which relates to or touches upon the V2 Motorcycle Run or the carrying out of the V2 Motorcycle Run.
7. To the extent permitted by law, the Entrant releases and forever discharges Variety - the Children's Charity and each Landowner from all Claims or Demands, whether known or unknown arising out of or relating to the V2 Motorcycle Run or the carrying out of the V2 Motorcycle Run.
8. This Agreement is governed by and construed in accordance with all state laws and statutes.
9. The Entrant must comply with the Variety Code of Conduct and V2 Motorcycle Run Rules. The V2 Motorcycle Run Chairman may require the Entrant to cease participation in the V2 Motorcycle Run if the Entrant fails to comply with the Variety Code of Conduct and any of the V2 Motorcycle Run Rules.
10. Further conditions of entry may be drawn up by the organiser and will be recorded in a regular Newsletter issued from the Variety office and the Entrant must comply with these further conditions
11. The decision of the V2 Motorcycle Run Chairman regarding any matter is final.
12. Definitions

In this Agreement:

"V2 Motorcycle Run" means name of SA Variety V2 Motorcycle Run

"V2 Motorcycle Run Chairman" means that person nominated by Variety - the Children's Charity to be in charge of the Event.

"V2 Motorcycle Run Rules & Regulations" means the rules set out in the document produced by Variety - the Children's Charity entitled "V2 Motorcycle Run Rules & Regulations".

"Claim or Demand" means any claim, demand, action, proceeding, judgment, order, award, damage or costs of any nature.

"Entrant" is an individual person that has been accepted to participate in the SA Variety V2 Motorcycle Run and also includes the legal or personal representatives of the person;

"Support Crew" means and includes (but is not limited to) each person travelling with a crew and each person assisting that crew in any way including (but not limited to) a mechanic, a member of a mobile repair crew or supply crew or any person acting in that capacity and their legal or personal representatives;

"Landowner" means and includes the owner, lessee or occupier of any land and any employee, agent or independent contractor of any such person. "Variety" means and includes Variety - the Children's Charity and each of its officers, member, employees, agents and independent contractors and any volunteer assisting it in connection with the V2 Motorcycle Run.

CODE OF CONDUCT

1. Entrants are to be aware that they will be seen as representatives of Variety South Australia and to behave accordingly.
2. Entrants will be instantly ejected from the V2 Motorcycle Run, without warning, in the following circumstances:
 - Actions that will compromise safety of the entrants and the general public
 - Detection by the Police for driving while under the influence of alcohol (over.05 or legal limit in state)
 - Offensive behaviour on a continuous basis
 - Assault
3. Entrants may be ejected from the V2 Motorcycle Run (for continuing transgressions) or refused entry to the next V2 Motorcycle Run, after being given one warning, in the following circumstances:
 - Bringing the name of Variety South Australia into disrepute
 - Excessive drunkenness
 - Tampering with other peoples' motorcycles or vehicles or possessions
 - Altering road signs or event signs
 - Vandalism
 - Refusing to obey reasonable directions of Officials or organisers
4. Any entrant ejected from the V2 Motorcycle Run will be automatically excluded from any future V2 Motorcycle Runs (this includes events conducted by other states).
5. These provisions apply to all crew members and any transgression by an **individual** entrant will result in the exclusion of **the crew** as provided above.
6. Variety South Australia will not be responsible for costs incurred by early exclusion from the V2 Motorcycle Run.
