In consideration of Variety - the Children's Charity (NSW), hereinafter known as Variety, permitting the Participant to take part in the Event in any capacity, the Participant acknowledges that:

- 1. the Event is a potentially hazardous event to those taking part and the Participant does so at his/her own risk;
- 2. the Participant must take out and maintain a comprehensive motor vehicle insurance policy and/or a third party property damage insurance policy for the Participant's vehicle including adequate cover for the Event, and the Participant must not do or suffer to be done anything which would enable an insurer to avoid or deny a claim under any such policy.
- 3. this Indemnity operates according to its terms and shall not be read down nor shall the Indemnity or Disclaimer be affected or altered in any manner, term or condition notwithstanding that the Participant may have been induced to participate in the Event by representations made by or on behalf of Variety:
